



VibeRx Affiliate Agreement

By filling out the signup form you acknowledge that you have read the terms and conditions, understand, and agree with them.

1. Joining the Program

After completion of this agreement you will be sent a website link by e mail to gain access to your affiliate website and marketing materials. This site allows you to track all sales, see who is clicking on your link and to track pending payments.

2. Requirements

You are required to own a VibeRx Whole Body Vibration System to participate in our Affiliate Program. Your participation in the program is solely for this purpose to legally advertise our website to receive a commission on products purchased by your referral individuals.

3. Revocation of Affiliate Status

Your affiliate application and status in the program may be suspended or terminated for any of the following reasons:

- Inappropriate advertisements (False claims, misleading hyperlinks)
- Spamming (mass email, mass newsgroup posting, etc...)
- Advertising on sites containing/promoting illegal activities
- Violation of intellectual property rights.
- Any action that would be detrimental to our brand or company reputation.

4. Affiliate Links

You may use graphic and text links both on your website and in emails. The site may also be advertised "offline" in classified ads, magazines, and newspapers. You may use the graphics and text provided to you by us, or you may create your own as long as they are deemed appropriate according to the conditions in 2.

5. Affiliate Tracking

When a web surfer uses your affiliate URL link, a cookie is set in their browser that contains your affiliate information. Also, their IP address is also tracked in our system along with your affiliate name. When this person purchases our product, our system will automatically credit your account with the commission. If the referring party does not use your link, there will be no credit for the sale.

6. Terms of the agreement

These terms will begin upon your signup with the affiliate program and will end

when your affiliate account is terminated. The terms of this agreement may be modified by us at any time. We will notify you of any modifications to this agreement. If any modification to the terms is unacceptable to you, you may choose to terminate your affiliate account. Your continuing participation in the program will constitute your acceptance of any change.

7.Commissions

Commissions are paid on the 1st week of the **first full** month following your referral purchases. For example, If your referral purchases a machine on the 15th of July, the commission check will be paid on the 1st week of **September**. If the product is returned to us for a refund during that period, no commissions will be paid.

VibeRX does not pay commissions for any purchases by relatives, or family members or on the purchase of any personal use machines.

Our Affiliate Program supports a 2 tier commission structure and tracks 2nd tier commissions for your clients who sign up as affiliates under your affiliate program.

The First Tier Commission payout is 20% of the retail price of the machine (not including shipping, handling, tax, or other charges).

The 2nd Tier Commission payout is 5%. This would be paid if a client referred by you refers another client to us. If you refer client Jones, and client Jones refers client Brown, client Jones receives the 1st tier commission of 20% (of retail) and you would receive a 2nd tier commission of 5% (of retail) on the client Brown sale.

VibeRx pays only one 1st tier commission and one 2nd tier commission per machine sold when applicable.

8.Liability

We will not be liable for indirect or accidental damages (loss of revenue, commissions, etc.) due to affiliate tracking failures, loss of database files, and any results of "intents of harm" to the program or our website. We do not make any expressed or implied warranties with respect to the affiliate program and/or products sold at this site. We make no claim that the operation of the affiliate program and our website will be error-free and we will not be liable for any interruptions or errors.
